## 1. DO YOU QUALIFY

- Home is not new construction.
- Home is electrically heated, includes heat pumps. Natural gas/oil/propane heated homes, not eligible.
- Purchase/Installation was within the last 90 days.
- Areas where insulation is being replaced must meet the following.
  - Attics: Original insulation R-value was R-19 or less and new insulation is R-38 or greater.
  - Floors: Original insulation R-value was R-19 or less and new insulation is R-30 or greater.
  - Walls: No original insulation and new insulation R-value is R-11 or greater.

Do you meet the criteria above for the areas where insulation is being replaced?
